Registration to apply for scholarships via OCU for the academic year 2020 for privately financed international students

If you want to apply for any scholarships via OCU, you need to submit the 'Registration form to apply for scholarships via OCU' at the start of the academic year and follow the procedures described below. Each time we receive information about available scholarships from scholarship organizations, we will announce those scholarships on the OCU Portal Site and the Global Exchange Office notice board. When you see a scholarship you want to apply to, and if you carried out the registration at the start of the academic year, you can apply via the OCU Portal Site. If you do not register to apply for scholarships via OCU at the start of the academic year, you will not be eligible for those scholarships.

- 1 Eligibility Applicants must satisfy both conditions below.
 - (1) Privately financed international students who are registered as regular (degree) undergraduate or graduate students **students who are repeating a year, research students and auditors may not apply.
 - (2) Students whose visa status is "Student".

- ① Application forms will be available between 16 March and 22 May 2020
- 2 Download the application form from the OCU UNIPA, prepare the necessary documents (in Japanese or English).
